

WHEREAS, the Notice Administrator has recommended, and the Parties stipulate and agree, that the claim filing and opt-out deadline should be extended approximately 45 days, to December 20, 2024; and

WHEREAS this adjustment of the claim filing deadline does not impact other deadlines of the Court's April 25, 2024 and in particular does not require any change in the date established for final approval hearing.
